#### Small fire extinguished in Malibu Canyon Sunday

Fire authorities extinguished a small brush fire in Malibu Canyon Sunday afternoon after dry conditions apparently sparked logs near Tapia Park, authorities said. The fire was small and was quickly extinguished.

A Los Angeles County Fire Department arson unit investigated the fire at about 2 p.m. Monday, concluding that a "warming fire" ignited a couple of logs, said Fire Captain Derek Bart of Fire Station 65.

In this particular instance, Bart said a warming fire is where logs appeared to warm in dry conditions and then caught on fire. The Malibu area has been under a Red Flag Warning due to extremely dry temperatures and low humidity recently, increasing the chances of such fires.

However, wind speeds were not high at the time of the fire, which limited its scope.

"Had the winds been there it would have been terrible," Bart said.

Malibu and surrounding areas have seen little rainfall in the past two years and are very dry due to the high winds and low humidity percentages. Bart said the dryness has increased the normal potential for fires.

"This is one of the worst seasons we've had on record," Bart said.

# Student arrested in Malibu for using a fake gun

What started out as a student movie project ended in an all-too-real encounter with local law enforcement on Thursday when a student was arrested for removing the safety tip from a replica handgun during an unauthorized film shoot on Little Dume Beach.

Malibu/Lost Hills Sheriff's deputies responded to a call around 10:30 a.m. last Thursday after witnesses reported seeing a man pointing a handgun at a female's head in the Little Dume area.

As California State Park rangers, county helicopters and Sheriff's deputies searched the bluffs in the area, they ultimately came upon a group of seven people, one of whom was filming a male pointing a gun at a female.

"An examination of the realisticlooking gun revealed it was a replica handgun with the orange plug tip removed. The orange tip was installed by the manufacturer to ensure people would know it was not real," according to the Los Angeles County Sheriff's Department.

The group told authorities they were filming a project for school but had not alerted law enforcement, obtained proper permitting or security or posted signs to warn about filming in progress.

An unidentified 20-year-old male film student from Valencia was taken into custody and charged with removing the fake gun's safety tip, a misdemeanor under state law.

### Trancas owners name new grocer



After months of uncertainty and rumblings over what store would replace the old HOWS Market at the Trancas Country Market in western Malibu, center representatives have confirmed the successor as Vintage Grocers, a new independent market.

Several banners went up on Wednesday displaying the new name and center representative Scott Rozier said he is hoping for a March 1 opening, with possibly a soft opening around Feb. 19.

Rozier had originally estimated a January opening but said he faced "a lot of delays during the holiday season."

The banners detail services to be offered at the grocery store: brick oven pizza, sandwich bar, juice bar, hot buffet and salad bar.

Rozier could not estimate how many people Vintage Grocers would employ, but a management team should begin the hiring process in the next few weeks.

Erewhon Natural Grocers had agreed in principle to occupy the former HOWS space in 2012, but backed out of the deal in September 2013, citing prolonged construction delays. The Trancas Country Market shop-

ping center is owned by Paige and Bo Dubbert. Paige Dubbert is the daughter of Wal Mart heiress Laurie Walton.

# Sheriffs arrest 16 at DUI checkpoint

Sixteen people were arrested, including three for DUI, on Friday night in Malibu at a DUI and driver's license checkpoint.

The checkpoint was staged on Pacific Coast Highway at John Tyler Drive and ran from 7 p.m. until 3 a.m. Saturday morning with 1,225 vehicles going through. One person was also arrested for an unspecified felony, one was arrested for driving under the influence of a controlled substance, and five were arrested and sent to court for driving without a license, according to the Los Angeles County Sheriff's Department.

## Residents report increase in coyote sightings

As Malibu residents are reporting more coyote sightings, especially in the Point Dume area, the city is advising residents to protect homes and pets from potential attacks.

According to councilmember Laura Rosenthal, "[Coyotes] are actually coming up on people's patios, backyards, even when there are people around ... I know with the drought, it's getting worse for them and they're coming down from the mountains."

The City of Malibu website provides some tips for keeping properties safe from coyotes:

Keep your cat or small dog indoors at night or any other time when a coyote is known to be in the area.

Accompany your small dog in a well-lighted area at night for comfort walks.

·Walk your dog on a leash whenever you take it off of your property.

·Confine poultry and rabbits in covered enclosures constructed with heavy mesh wire. Coyotes can break through ordinary chicken wire.

 Keep all outdoor trash can lids securely fastened to trash containers.
Pick backyard fruit as soon as it ripens and keep rotten fruit off the ground.


