The benefit of building

In response to "Commission Delays Approval of Bluff-Top Homes," I think it's important that we not lose sight of what this project is and how it benefits Malibu.

The project that was presented to the Planning Commission last Monday night called for five homes on a 24-acre site directly adjacent to Bluffs Park. It also called for a donation of sufficient land to add a baseball field or skate park and additional parking to serve the existing amenities.

The next time you spend a quiet afternoon with your family at Bluffs Park, take the time to view this vast plot of vacant land. Then imagine a boutique hotel in its place or a large-scale condo complex, both of which have been proposed for this site in

Now imagine five homes. The developer has offered to reduce the height and visible bulk of the homes as well as to modify the landscape plan to make the project less apparent when viewed from all locations. In a city where low density and slow growth win the day, one would assume that Malibu would embrace a dramatically reduced plan like this. And, in fact, it has.

Our youth sports community, among many others, has voiced its support for the project as it represents an opportunity for the city to fill a major void in the lack of active park space. So, whether it's the land donation, the \$1 million to finance construction of the new park space or the port this project, and you should too.

improvement to the nightmare that is parking at Bluffs Park, this project will benefit residents and visitors alike.

I think somewhere between the lengthy public testimony and the sidebar about concerns that the Staff's recommendation to preserve the option of zoning other properties' "planned development," we lost focus on what this project is. The plans satisfy our Planning Department as seen by its affirmative recommendation in the staff report. It clearly meets the requirements of Malibu's strict zoning code. And lastly, the developer is giving something back to the community that we all want.

Finally, as Arnold York stated quite eloquently in his Editorial dated Jan. 8, "Many people live behind or adjacent to an empty lot and once they get used to that view, they get very upset when someone comes along and wants to build on that vacant lot because that new house is going to cut down part or all of their view. That's the reason we have a zoning code, so it isn't a popularity contest. I have a right to build on my lot just the way you have a right to build on your lot, just as long as I do it within the rules relating to height and bulk. Many have trouble with that concept, but zoning can't be that whoever builds first wins and is therefore able to block everyone else from using their lot."

The importance of a view

The Malibu Times' article, "Commission Delays Approval of Bluff-Top Homes," (Jan. 8) claims it met with pushback at the Malibu Planning Commission. My friends and I disagree—it sailed through, mostly led by a partial Chairman Jennings. The Planning Commission voted 3-1 to recomwent on to establish development standards for the project.

I understand that staff sent commissioners a 2,700 page package, knowing full well they had no time to read it, and yet still recommended a vote of yes on the project.

Commissioner John Mazza consistently questioned, with surprise, that the project might be approved without the usual considerations.

It was noted that the developers are offering a donation of one million dollars to the city. The Supreme Court recently ruled that cities are barred from accepting donations. The ensuing discussion attempted to get around that.

Our family has lived in Malibu Colony for over 50 years. That looming development would sit immediate stage right of the sunset for Colony residents and would mar the pristine mountain profile of so many highly prominent and well-populated perspectives within the heart of Malibu.

This bluff top is such an important ridgeline as viewed by so many. As a destination, the park is a cultural landmark that should be considered a public good and, thus, not just relevant to those within the immediate vicinity. I

also note that the City admitted that "view was not one of the main criteria considered by them" in 2009 when they allowed the zoning change.

In the discussion of the Ridgeline Ordinance, the Commission considered whether this bluff top should be so restricted, claiming technicalities of slope as reasons why it doesn't qualify as a "ridge," per se. The point mend to certify the EIR and even worth underlining is that the purpose of the ordinance is to protect prominent view sheds as seen on busy thoroughfares like Malibu Canyon, which this development certainly would ruin.

Keeping coyotes away

Yesterday during breakfast, a covote came within six feet of my back door with eyes on two little dogs behind a barking Labrador Retriever. This is the first time in 25 years on Point Dume that a coyote has been so fearless. I wanted to share some tips on creating "unfriendly" coyote neighbor-

Q: Why are they in my neighborhood?

Because of the recent fire and ongoing drought, many wild animals have lost their habitat and are looking for new sources of food and water.

Q: What can I do to make my home and neighborhood undesirable to covotes?

When coyotes find food sourc-

es in residential areas, they may lose their fear of humans and eventually test both people and pets as prey. Do not feed covotes either intentionally or by accident as this causes them to quickly lose their fear of people and become aggressive. Anyone who feeds coyotes is putting the entire neighborhood's pets and children at risk of coyote attack and serious injury.

-If you feed pets outdoors, food dishes should be promptly emptied and removed after pets have eaten.

-Store pet food indoors or in sealed heavy-duty containers.

-Use containers that have tight-fitting lids to prevent raccoons, dogs or coyotes from having access to household garbage.

-Make sure ripe fruits are picked from the garden.

-Keep grills and barbecues clean. Even the smallest food scraps may attract coyotes.

-Do not allow spillage to collect under bird feeders.

Q: How do I keep my family pets safe?

Watch your pets: keep small pets such as cats, rabbits and small dogs indoors, and if outdoors, keep them within enclosed kennels. Large dogs should be brought inside after dark. Never allow cats or small dogs to run free at any time, as they are easy prey. Remember invisible fencing is ineffective on coyotes.

Q: What happens if I encounter a coyote?

If you see or are approached by a coyote, you should exhibit caution. Do not run away. Instead, yell, wave your arms and/or throw an object at the animal. It is a good idea to carry a walking stick.
