#### Man dies at Zuma Beach

A 66-year-old man identified as Bharat Talsana died Monday afternoon at Zuma Beach of an apparent heart attack.

The man was reportedly not in or near the water at the time of his death, and initial reports that the man drowned have since been discounted.

According to authorities, the man suffered the heart attack around 3:30 p.m. Monday near Zuma Beach Lifeguard Tower 1, located on the eastern section of the shore, and could not be resuscitated by lifeguards or fire personnel.

Talsana was a resident of Arcadia, and was reported to be visiting the beach with a friend when he collapsed.

### Council to decide on Reiner Initiative next week

The Malibu City Council will meet next Monday night to decide on an initiative locals are hoping to place on the November ballot.

The Rob and Michele Reiner-led "Your Malibu, Your Decision" initiative aims to curb the number of chain stores that open in Malibu and would allow residents to vote on proposed development projects of 20,000 square feet or more.

Following orders from the City Council last month, city staff has prepared more than 100 pages of reports addressing several areas of concern over the proposal, including its legality and the responsibilities the city would undertake in enforcing it.

Theoretically, the Council could pass the ballot initiative as written on Monday, order it be placed on this year's November ballot when a countywide election is scheduled, or delay it until the next local election in April 2016.

## DUI checkpoint scheduled in Malibu

The Los Angeles County Sheriff's Department will conduct a DUI and driver's license checkpoint in Malibu on Friday, July 11 from 7 p.m. until 3

a.m. Saturday morning.

Checkpoint locations are not disclosed beforehand.

The checkpoints are designed to prevent drug/alcohol related incidents. Drivers will be screened for impaired driving, as well as proper driver's licenses, by the LA County Sheriff's Department's Malibu/Lost Hills Station. Drivers caught driving under the influence of drugs or alcohol could face penalties ranging from insurance increases and DUI classes, to jail time, license suspension and fees exceeding \$10,000.

According to the Sheriff's Department, "The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes."

## Cause of drone crash determined

A malfunctioning control system and human error were the causes of a drone crash that damaged the USS Chancellorsville and injured two sailors off the coast of Point Mugu on Nov. 16, according to a U.S. Navy report released this week.

Two sailors suffered minor burns and a fire broke out when the 13-foot unmanned drone hit the missile cruisers hull as the ship was practicing training drills.

Initial Navy reports were redacted and had previously stated equipment malfunctions caused the crash.

A target control team at Point Mugu had launched the drone at the ship to test the ships ability to protect the crew from enemy missiles. Once the drone was close to the ship, the team ordered it to turn away and the drone ignored the command.

The crew on board the USS Chancellorsville failed to apply a "rogue drone" alert and also neglected recommendations to fire on the approaching drone.

A report from Pacific Fleet Commander Adm. Harry B. Harris Jr. described that virtually everyone involved in the exercises believed the chances of a drone hitting the ship were extremely remote, so they focused on targeting and data instead of the safety concerns.

The leadership at both Point

Mugu and the USS Chancellorsville had opportunities to prevent the crash and failed to do so, according to Harris' report.

After the findings, administrative actions were taken against the ship's commanding officer, tactical action officer, anti-air warfare coordinator and combat system coordinator.

The USS Chancellorsville was docked at Naval Base San Diego after the strike for repairs that took about six months and totaled over \$30 million, according to a Navy Times report.

#### Lane closures slated for bike route project in western Malibu

As construction gets under way for a bike lane improvement project in western Malibu, the city is planning periodic lane closures and delays on Morning View Drive and Pacific Coast Highway through August 19.

The PCH Bike Route Improvement Project includes the addition of a dedicated right turn lane onto Morning View Drive, which will relocate the bus stop. Drainage and sidewalk improvements are also planned.

The second phase of the project begins after Labor Day and the project should be completed sometime in the fall.

Other improvements include installing a bike lane in the Zuma Beach area, bike route improvements from Busch Drive to the western city limits and improving the Trancas Canyon Road intersection at PCH.

- 4. Conduct him/herself in a dignified and professional manner, treating everyone with civility and respect.


#### Malibu Film Society celebrates 'Hard Day's Night' anniversary
