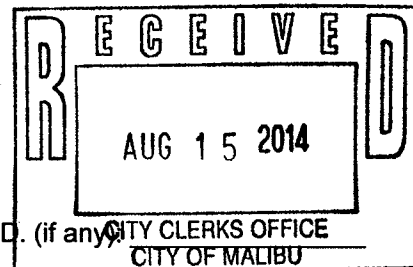

Malibu is threatened by development and traffic.

But today Malibu is threatened by over 1.5 million square feet of new development, which would drastically increase traffic, destroy open space, and impede fire evacuations.
